Minutes of Logan Soccer Club

The last meeting of the Logan Soccer Club was held on April 6, 2010.

Those present were: John Mauger, Vinnie Hickman, Bud Gold and Gina Bradson.

The meeting was called to order at 8:40 PM. Previous minutes were read and accepted. It was noted that John Kane and Brian Cielinski had resigned from the board due to personal obligations. Both will continue to help out and coach for the club.

Treasurer: Buddy reported we owe approximately \$3,000 to MVP Sports for paint, patches and sweatshirts. John received a quote of \$2,033 from landscaper Armand Palimeno to fix the damaged areas of the fields. The board agreed that this should be done. John will contact him and get it scheduled. The club also owes about \$2,500 for lights. The other expenses to be incurred are: stop watches for coaches \$200, game balls \$500 and concession stand items. We have not yet heard from the township regarding the \$5,000 grant. John will contact them to see if they have decided on whether or not they plan to award this to our club for this year. The taxes still need to be looked in to further. Gina and Buddy will look in to this together.

Fields & Equipment Coordinator: John Mauger

- All fields were set up and lined on March 6, 2010.
- A field lining schedule was sent to all coaches for Spring season.
- All the supplies will be picked up from MVP Sports soon. Vinnie said that MVP is convenient and good. She wants to use them and not the Deptford Soccer Post that presented at last meeting.
- The board talked over the idea of having a work-bond for next season. They will discuss this further at future meetings.

Registration & Uniforms Coordinator: Vinnie will send the updated registration file tonight after the meeting. It was suggested that for the boys that have not paid, that they should be asked for \$20.00 and put on a payment plan. If they do not pay, then their card will be pulled. This was acceptable to the board.

Tournaments: No new talks on this. It was decided at the last meeting that this is an area that the board would like to get in to for 2011.

Training:

New Business:

- Paul Nyce is interested in joining the board. he will not be able to be on the board but can be a member due to his daughter playing for Logan.
