Minutes of Logan Soccer Club

The meeting was called to order at 7:44 PM. Previous minutes were read and accepted.

Special Guest: Armand Palimeno (Landscape) is going to survey the damaged areas on the fields and provide us a cost for fixing these areas. Once weather is cleared up he will send an assessment to the board.

Treasurer: The Treasurer's report was not read nor accepted. Buddy was not present for the meeting but is preparing the monthly as well as the end-of-year report and should have to all members by end of week Feb 12, 2010. Gina Bradson was nominated and accepted as the new treasurer. Bud Gold has resigned the position as treasurer. Bud will provide all paperwork plus the Quick Books program to Gina.

Fields & Equipment Coordinator: Brian Cielinski provided a report on the status of the grounds as well as equipment.

- Fifteen cases of paint will be ordered by John Kane from MVP.
- Brand new nets were found in the shed. We will use for the spring.
- The far field needs to be rested for a year or two; agreed by the board to rest it.
- Fields are on schedule to set-up for Feb 13, 2010 (weather permitting). Rain date is the following week, Feb 20, 2010. Need support from all members to get this accomplished. Email was sent out to all coaches on Feb 8, 2010 by Brian.
- Brian to converse with John Kane about ordering new soccer balls (size 4 and 5).
- John Kane will handle the ordering of the patches.

Registration & Uniforms Coordinator: Ron Hickman will make sets of twenty "20" flyers. He will get flyers printed to give to Marisa Gold to distribute for those children in grades Pre-K through 3rd.

- Registration is slow for the travel teams but should be completed before the March 6, 2010 deadline.
- Micro-mini currently has around 50 players registered.
- John Kane inquired about ordering uniforms for the U9/U10 teams. The board concluded that they should use their previous uniforms and the club should not incur an additional cost. John Kane did request that would the club be okay with paying a partial cost if he was able to get the money elsewhere. The club did seem okay with possibly doing that; proposal will be forthcoming at the next meeting.

Tournaments: Brian Cielinski, John Kane and Ron Hickman are working on gathering information in regards to holding 3 v 3 tournaments in August. After more information is obtained, including statistics from other local tournaments, a final decision will be made. The formation of a tournament committee was also broached.

Training: John Kane is setting up an "E" & "F" license course in the summer.

- F license course will be held at the Logan School
- E License will be held at the Logan Township building in August (need classroom for two Fridays – tentative dates would be Aug 20 & 27, 2010). John Mauger, setting up classroom with the township, will have status at the next meeting in March.
- KIXX or Independence Camp for the summer? John Mauger going to inquire with Independence for a possible Camp. Trying to see what they would offer the club verses what KIXX has done in the past. Kixx has given us a kick-back of \$10 a player but last summer we only had 22 kids show up; not good.
